**POSITION:** Conservation Lands Field Assistant - two positions (dependent on confirmation of funding)

### DUTIES:

- Perform property groundskeeping, including lawn cutting, weed trimming, digging, raking, and planting.
- Assist with habitat restoration projects.
- Assist with development, maintenance and repairing of trails and facilities, including painting, fencing, grading, shoveling and garbage collection.
- Safe operation and maintenance of small engines, equipment and tools.
- Assist with setting up and dismantling of program events as required.
- Adhere with all LTC policies and procedures.
- Undertake other related duties as assigned.

### QUALIFICATIONS:

- Undertaking or completed post-secondary education (park management, outdoor recreation, ecotourism).
- Physically fit and some heavy lifting (~22 kg) required.
- Experience with groundskeeping equipment preferred.
- Experience painting considered an asset.
- Experience with habitat restoration, management, and monitoring considered an asset.
- Ability to work outdoors under various environmental conditions as required.
- Valid driver's license within the Province of Ontario and held in good standing.
- *To be eligible, you must be between 15 and 30 years of age at the start of the employment; be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment (international students are not eligible); and, have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.*
