# PROPOSED RESOLUTION:

THAT pursuant to subsection 48(2) of the *Clean Water Act*, 2006, Anne Anderson be appointed as a Risk Management Official/Risk Management Inspector for the Lower Trent Source Protection Authority; and

THAT pursuant to subsection 48(2) of the *Clean Water Act*, 2006, Marcus Rice be appointed as a Risk Management Official/Risk Management Inspector for the Lower Trent Source Protection Authority.

# **BACKGROUND:**

The Trent Source Protection Plan contains some policies that regulate significant drinking water threats using Part IV of the *Clean Water Act.* Municipalities are responsible for administering these Part IV policies; however, they have the option of transferring their enforcement authority to another body (e.g., Health Unit, Conservation Authority).

Lower Trent Conservation, in its role as a Source Protection Authority, has entered into a Source Protection Plan Part IV Enforcement Transfer Agreement with five municipalities (Township of Alnwick/Haldimand, Municipality of Brighton, Township of Cramahe, Township of Stirling-Rawdon, and Municipality of Trent Hills). The agreement empowers Lower Trent Conservation to provide Part IV enforcement services on behalf of the participating municipalities.

The Source Protection Authority must appoint Risk Management Officials and Risk Management Inspectors pursuant to subsection 48(2) of the *Clean Water Act, 2006* to administer and enforce Part IV policies.

# **DISCUSSION:**

Anne Anderson has been an appointed Risk Management Official for many years, this confirmation of appointment is to ensure no time limit on the appointment as long as she is an employee of LTC.

Marcus Rice was hired as in the Risk Management Official position in late September 2022. As the successful candidate, Marcus had to complete the required Ministry of the Environment, Conservation and Parks (MECP) training before being able to fulfil the job requirements. Marcus successfully completed the Risk Management Official/Inspector and Property Entry courses in late 2022 and has received both his certificate of qualification and his completion certificate from MECP.

Further, the Minister has approved the designation of Source Protection Authority appointed Risk Management Inspectors (where they are enforcing Part IV of the *Clean Water Act* pursuant to a signed delegation agreement) as Provincial Offences Officers under the *Provincial Offences Act*. The designation remains in effect during the period of an individual's appointment as a Risk Management Inspector by a Source Protection Authority.

The designation by the Minister indicates that a certificate of designation as a Provincial Offences Officer is to be issued by the Source Protection Authority to applicable Risk Management Inspectors.

## PROPOSED RESOLUTION:

THAT the Lower Trent Source Protection Authority Annual Progress Report for the period January 1, 2022 to December 31, 2022 be received as information.

# **BACKGROUND:**

Section 46 of the *Clean Water Act* and Section 52 of Ontario Regulation 287/07 articulates that the Source Protection Authority must prepare and submit an Annual Progress Report to the Source Protection Committee at least 30 days prior to submitting it to the Ministry of Environment, Conservation and Parks (MECP) by May 1<sup>st</sup> of each year.

To prepare this annual progress report, information was provided by the various implementing bodies to the Source Protection Authority by the due date of February 1, 2023. This information was consolidated into the attached report and includes commentary on the implementation of policies.

Within the Lower Trent Source Protection Area, overall implementation of the Trent Source Protection plan is "progressing well / on target". Most of the source protection plan policies have been implemented and/or are progressing according to the timelines in the source protection plan.

The completed Lower Trent Source Protection Authority template was rolled up with the other three Source Protection Authority templates into an Annual Progress Report for the Trent Source Protection Plan and provided to the Source Protection Committee at its meeting on March 30, 2023.

The following is a summary of the progress for the Lower Trent Source Protection Authority for the period between January 1, 2022 and December 31, 2022.

- All municipalities (100%) within the Source Protection Area have established standard operating procedures to ensure that day-to-day planning decisions conform to the Source Protection Plan.
- 75% of municipalities have ensured amendments to Official Plans and Zoning By-Laws conform

to the Source Protection Plan. The remainder have plans in place to complete this within the timeframes specified in the Trent Source Protection Plan.

- 95% of municipalities have ensured updates to Emergency Management Plans are complete.
- In 2022, 3 septic threats were inspected for the second round of the 5-year cycle for mandatory inspections.
- 4 Risk Management Plans addressing 7 significant drinking water threats were established by Risk Management Officials in the Lower Trent Source Protection Area (total of 46 Risk Management Plans addressing 73 significant drinking water threats since implementation).
- 65 Section 59 Restricted Land Use notices have been issued (total of 241 since January 2015).

Lower Trent Conservation delivers Education and Outreach for all applicable municipalities. In 2022 activities included:

- Advertisement in municipal Community Guides
- 15 social media posts reaching approximately 5000 people
- Supported the provincial road sign campaign
- Reached ~1000 students, teachers and parents through the Tri-County Children's Water Festival
- Reached ~1000 children through virtual and in-person programming.
- Reached over 2000 people at community events including LTC Farewell to Frost, Quinte West
   Wellness Expo and the Hastings County Plowing Match

The following table summarized the progress of Provincial Ministries in implementing policies for which they are responsible.

#### PROPOSED RESOLUTION:

THAT staff be authorized to submit the 2022 Trent and Ganaraska Source Protection Plan Annual Progress Reports to the Ministry of the Environment, Conservation and Parks as required by Section 46 of the Clean Water Act and Section 52 of O. Reg. 287/07, along with any comments received from the Source Protection Committee be approved.

# **BACKGROUND:**

All significant threat policies in the Source Protection Plan, have a companion monitoring policy that requires the person or body responsible for implementing the threat policies to report every February 1<sup>st</sup>, on the progress made during the previous calendar year.

Lower Trent staff receives these reports from all five of the Trent Conservation Coalition Source Protection Areas and roll them up into two Annual Reports. One report for the Trent Source Protection Plan and one for the Ganaraska Source Protection Plan (see attached Annual Reports).

# **DISCUSSION:**

The results of these reports were presented to the Source Protection Committee on March 30, 2023 to allow the Committee to assign a level of progress to the reports. By consensus, the Committee determined that for both reports, the program scored a "Progressing well / on target" rating and the Committee approved the information provided in the Annual Reports.

There are two issues that were identified through the Annual Reporting effort, that need to be addressed:

- 1) There are still a few outstanding Risk Management Plans in the Kawartha-Haliburton area that are required but have not been completed. Steps are being taken to address this situation as soon as possible.
- 2) One municipality in the Lower Trent area has not updated their emergency response documents as per Policy G-11, to reflect source protection vulnerable zones and the appropriate measures that need to be in place in the event of an emergency in those zones. The Township of Alnwick/Haldimand needs to update their emergency response documents done as soon as possible.

The next step in the process is to seek approval from the Lead Source Protection Authority (the Lower Trent Source Protection Authority) to submit the 2022 Trent and Ganaraska Source Protection Plans Annual Progress Reports to the Ministry of the Environment, Conservation and Parks, as required by Section 46 of the Clean Water Act, along with any comments received from the Source Protection Committee. No comments are being sent from the Source Protection Committee this year.

# **BACKGROUND:**

The Section 36 Amendment Package was submitted to the Ministry of the Environment, Conservation and Parks for Early Engagement, on December 20, 2022. In early February, 2023 we received comments. There were no issues with the intent of our policy amendments and only minor edits requested to improve the language and terminology in the Assessment Reports and Source Protection Plans. Staff have had several meetings with the Ministry and the necessary changes have been made. The revisions were presented to the Source Protection Committee on March 30, 2023 and the Committee approved the changes.

The Committee is requesting that the Lower Trent Source Protection Authority approves sending out the amendment package for the next phase of consultation, pre-consultation. Pre-consultation is designated for a prescribed list of provincial ministries, all municipalities and all First Nations within the Trent Conservation Coalition Region. The pre-consultation will occur in May 2023, once necessary letters and packages are ready to send out. The pre-consultation will run for 30 days.

#### **BACKGROUND:**

The retirement of Rosemary Kelleher-MacLennan left a vacancy for a Lower Trent Source Protection Area municipal representative on the Source Protection Committee. Lower Trent staff consulted with the municipalities in the Lower Trent Source Protection Area and requested nominations to fill the vacancy. One name was submitted and the all municipalities have endorsed this candidate. Anne Butwell from Brighton, has been nominated to be the municipal representative for the Lower Trent Source Protection Area.

The Kawartha-Haliburton Source Protection Authority is going through the process to select two new municipal representatives. At this time, they have selected and received endorsements from their member municipalities for Cecil Ryall from Highlands East. They are still working to replace the second member.

## REPLACEMENT OF THE ENVIRONMENTAL NON-GOVERNMENT REPRESENTATIVE

The individual representing the Non Government Environmental Sector has resigned from the Committee and the position needs to be filled. The application process ended at the end of March. Two application have been received and the selection committee will be making their recommendation as soon as possible. Once a candidate has been selected, an email poll of the Lower Trent Source Protection Authority will be conducted to appoint that person to the Source Protection Committee.
