#### 10. Monthly Payments Issued

Director Ainsworth inquired as to the LTC insurance payment and coverage. The Board members shared similar experience of 35% - 45% increase in insurance premiums. Kelly Vandette, Manager, Corporate Services stated that LTC is a member of the Conservation Ontario Authorities insurance group brokered through Marsh Insurance and rates are reviewed annually by a committee. Being part of this committee provides the best possible group rates; especially if there are claims against smaller CAs such as LTC. Coverage for errors and omissions, liability, and property are complex and costly.

#### 11. Watershed Management, Planning and Regulations Reports

Gage Comeau, Manager, Watershed Management, Planning and Regulations spoke to the staff report as provided in the agenda package.

There are two hearings anticipated coming forward, one for June and other to be determined.

Flood Forecasting and Warning Report noted that LTC flood messages exceeded the numbers over the past three years. Lake Ontario has risen over past few weeks, is at flood warning levels and is being monitored. Largest concern is for forecasts of high southerly winds.

Director Wheeldon inquired as to the reason for increased communication statements. Gage Comeau indicated that the increase was due to more recent precipitation events.

Director Hamilton, inquired as to the geographic township references in the permitting summary. Gage Comeau responded that the geographic township information is based on historic township that does not necessarily correspond to the current ward or municipal boundaries.

Director Sandford requested clarification on one of the legal cases as to when a decision will be reached. Gage Comeau responded that the next in court date is scheduled for June 21<sup>st</sup>. The decision of the Justice of Peach (JP) will follow sometime after that date. The Board will be informed as to the JP's decision.

Director Reid indicated that the free screening for planning applications as noted is positive and creates a positive relationship working with residents. Director Wheeldon agreed and commented that he appreciates that LTC is not charging fees for this. Gage Comeau confirmed that preliminary consultations are free but fees will be charged depending on the outcome of the reviews.

Chris McLeod, Conservation Lands Supervisor responded that the trucks listed may not be available now as there is a back log for orders. Test drives were conducted on these vehicles. He will look into the availability of these trucks again.

Direct Alyea asked if we would consider to tender out for vehicles to get a better rate.

Chris McLeod commented that as LTC's fleet is small we may not reap the saving applied to larger fleet purchases. Rhonda Bateman commented that the Capital Asset plan amounts allocated spaced out purchases over time and prices have increased substantially.

Rhonda Bateman commented that LTC may have to lease a vehicle if a purchase cannot be finalized during the current field season.

#### 17. Members Inquiries/Other Business

- a. Bill 23 Director Ainsworth said that the Township of Alnwick-Haldimand Council requested information as to whether there would be a levy decrease due to Bill 23. Rhonda Bateman responded that the changes in Bill 23 affect the natural heritage review that was paid for by the proponents, not the municipal levy. Our planning comments on natural hazards and wetlands are still active and that is the aspect paid for by the levy. Our reviews are thorough and the planning files are still required to move through the CA. The natural heritage portion of the reviews was often not present, the workload continues. Ultimately, these changes are increasing the cost to the developers and municipalities for necessary peer review. provided explanation that it does not affect the levy. She will provide written response for Director Ainsworth to take back to AH Council.
- **b. ATV Trails** Director Ainsworth shared about the ATV trails and the there are organizations are trailing on areas not permitted such as wetlands. Director Ainsworth asked if the LTC Board can act upon the issue. CAO Bateman responded that LTC can only enforce on LTC properties but would be happy to assist in sharing messaging.
- c. Rainbow Trout run has been bad in Shelter Valley and wondered if fallen trees in the river has had some effect. Can LTC support tree removal. Rhonda Bateman noted that if the intent is to move the trees by hand permits are not required but be aware of requiring permissions to enter private properties. Machine tree removal will require a permit from LTC.
- **d.** Watershed Tour Rhonda Bateman invited the Board Members to a tour of the LTC watershed as part of their orientation and proposed date of June 14 or 15. She will follow-up once attendees are confirmed and date is scheduled.







#### Legal Cases:

- **ENF-19-010** Trial on-going. 3 court dates set (April 26, May 3 and June 21). Staff have completed two of three trial dates. The defendant is looking to appeal the 11(b) charter decision that was decided in April. The Trial is scheduled to continue and the appeal will take place following the results of the trial. - ENF-20-028 Trial Date: January 9, 2023 May 17, 2023 Justice of the Peace Le Blanc imposed a fine of \$5,000 per count for a total of \$15,000 in addition to a restoration order. Status: Trial and Sentencing Completed.
- **ENF-21-005:** First appearance was set for May 3, 2023; however, due to an illness the Justice of the Peace was unable to attend court on the scheduled day and the matter was pushed to June 7, 2023. Property owner has been working with staff to come to a resolution; however, due to the statute of limitations noted in the *Conservation Authorities Act* charges were laid to continue resolution discussions. Status: **ONGOING**

• Wetland assessments have begun for this year. Individuals on the wetland assessment list are being contacted to gather permission to enter the lands and complete the assessments as requested.

• The LTC monitoring programs have commenced and the summer students have completed their training with Scott Robertson, Watershed Services Technician. Staff are looking forward to completing another year of monitoring, so we can continue to review and assess the health of our Watershed.

#### Permitting:

- Two permit applicants are looking to proceed with a hearing as the proposed development activities do not
  comply with the LTC Board Approved policy document for the administration of Ontario Regulation 163/06. These
  matters will be brought to the Hearing Board for the <u>July Board Meeting</u>.
- LTC staff have been in discussions with applicant team for Permits B, D, E and F for the Hillside Meadows North Subdivision or York Creek Development Area in the City of Quinte West (RP-21-379; RP-22-047; RP-22-048 and RP-22-049). Hearing was held on June 9, 2022 where all applications were approved by LTC Board. LTC staff were waiting for confirmation of wetland delineation, a wetland compensation plan and detailed drawings of watercourse alterations and crossings. Permit B was issued by staff on May 23, 2023. Additionally, a formal submission related to the wetland delineation and compensation have been received. Staff are currently reviewing the report.

#### Planning:

- LTC Staff reviewed and commented on 6 Subdivision and Condominium Files in 2023 (new and ongoing).
- LTC Staff reviewed and commented on 9 Planning Act Applications (Severances, Zoning By-law amendments and/or Minor Variances).
- REMINDER LTC staff are providing free screening services for planning applications to ensure that applicants do
  not have to pay LTC planning application fees when LTC would have no comments. Municipal planning
  departments have been encouraged to circulate ALL planning applications for LTC screening.

Lastly, kind reminder to let your Municipal staff know that LTC is here to assist our Municipal partners where possible. LTC Staff can walk landowners through our permitting process, the planning process and other procedures/processes that may be applicable to their proposal or inquiries. LTC Staff are incredibly knowledgeable and we are here to help the residents of our Watershed.

#### **Summary of Current Conditions**

Based on the information collected at the Environment Canada Rain gauge located at CFB Trenton, May has been a fairly dry month when compared to the long-term average for the month of May (May 2023, **43.2mm** vs. **79.4mm**, May Long-term Avg., see Table 2.). Long-range forecasts for June are showing a potential for cold to mild temperatures and the potential for below average precipitation. A further look into the long-range forecast shows warmer than average temperatures for July with the potential for average precipitation. Staff will be reviewing for potential low water concerns within our watershed.

To date, LTC staff have issued a total of **15** flood communications with **1** communication being issued in the past month.

#### **Local Creeks**

The local creeks within our watershed are sensitive to local area rainfall and are subject to quick increases and decreases in stream flow. Most of the local creeks see a peak in stream flow conditions within 24-48 hours after a rainfall event.

UPDATE - In this past month, the creeks have shown little flow response due to the lack of rain the watershed has received. The majority of the local creeks are seeing higher than average flows when compared to the long-term averages for this time of year. This is likely due to the large volume of precipitation that was observed in the first four months of 2023.



#### **Trent River**

UPDATE - The Trent River is showing seasonal flows and water levels at this time. Staff continue to review the conditions daily to ensure that our messaging is up to date.

#### Lake Ontario

UPDATE - A Flood Watch Statement was issued by LTC Staff for Lake Ontario on May 5, 2023. Lake Ontario and the Bay of Quinte water levels continued to see a seasonal rise until it reached a peak elevation of 75.4 metres IGLD on May 14, 2023. Since observing the peak elevation, the water levels have been on a slow decline (1-2cm/day decrease); although, based on the declines observed so far, staff will likely be downgrading the Flood Watch statement to a Shoreline Conditions Statement, prior to the Board Meeting date of June 8, 2023.

Water levels thus far have been well below the observed water levels of 2017 and 2019. It is important to understand that the water levels on Lake Ontario naturally vary, responding to a variety of factors on a monthly, seasonal and annual basis. Water levels are primarily influenced by natural factors including precipitation, evaporation, winds, runoff from creeks and rivers and inflow from upstream Great Lakes. Lake Ontario typically reaches its seasonal highwater levels in May/June.

#### **RECOMMENDATION:**

Staff recommends to the Board of Directors that the Flood Forecasting and Warning Update be received as information.





Here's a topic not many people think about. Wastewater! Did you know there are different kinds? Did you know wastewater often ends up in the same body of water as where your drinking water comes from?

Wastewater is a term typically used to describe liquid wastes from two types of sources. The first source, sanitary sewage, is generated from homes, businesses, institutions and industries. The second source, stormwater, is generated from rain or melting snow that drains off rooftops, lawns, parking lots, roads and other urban surfaces.

Wastewater is collected by sewer systems.

There are two types of wastewater collection systems;

- 1. a combined sewer, and
- 2. a separate sewer system.

Combined sewer systems combine both the sanitary sewage and stormwater collection. During periods of heavy precipitation, overflows caused by overloading the combined sewer collection system may result in a direct discharge of partially treated sewage into waterways.

On the other hand, separate sewers have isolated the sanitary sewage collection from that of stormwater collection. These days, wastewater treatment plants have compliance orders that set limits on their discharge. For example, around the Bay of Quinte effluent discharge rates for phosphorus are 0.3mg/L and most of the plants bordering the Bay are meeting or exceeding this requirement. **More info on wastewater** 

However, stormwater is a different matter, while new developments must meet stormwater guidelines, many older sections of urban areas still discharge stormwater directly into the nearest body of water - untreated. A substantial number of stormwater outfalls to the Bay of Quinte have no water quality management features.

Urban stormwater runoff makes a significant contribution to the phosphorus loads entering the Bay of Quinte. Lawn fertilizers, soil, dust, litter and pet waste all add phosphorus to stormwater as it races across urban pavements. As urban areas expand to accommodate population growth, phosphorus loads are expected to increase.

There's an old saying, "If you don't want to drinking it, don't let it go down the storm drain."

Some ways homeowners can help reduce pollutants from entering local water ways are:

- Wash your car on a lawn or other unpaved surface to minimize the amount of dirty, soapy water flowing into the storm drain.
- Check your car, boat, motorcycle, and other machinery and equipment for leaks and spills.
- Use pesticides and fertilizers sparingly. Avoid application if the forecast calls for rain.
- Select native plants and grasses that are drought and pest-resistant.
- Sweep up yard debris, rather than hosing down areas.
- Compost or recycle yard waste when possible.
- Clean up spills immediately, and dispose of the waste safely.
- Store substances properly to avoid leaks and spills.
- Purchase and use nontoxic, biodegradable, recycled, and recyclable products.
- Properly dispose of hazardous products through a household hazardous waste collection program.
- Reduce the amount of paved area and increase the amount of vegetated area in your yard.
- Consider directing downspouts away from paved surfaces onto lawns.
- When walking your pet, remember to pick up the waste and dispose of it properly.
- Build a rain garden.

#### **EUTROPHICATION OR UNDESIRABLE ALGAE**



The current Bay of Quinte Remedial Action Plan phosphorus target was established in 1993. The target is 30  $\mu$ g/L in the upper Bay of Quinte for the May to October time period. The bay is regularly meeting the established phosphorus target and it is recommended that this target be used to change the status of the **Eutrophication and Undesirable Algae** environmental challenge and delist the bay from the Areas of Concern list.

However, over the years, scientists have recognized how complicated the ecosystem is. Current research and modelling studies highlight that despite major reductions in phosphorus loads to the bay, the ecosystem still shows the characteristics of a eutrophic system.

To further reduce phosphorus levels and ensure long-term protection of the bay's water quality, a Phosphorus Management Plan is being developed for the bay. It will establish new long-term targets. These targets have been recommended based on modelling studies conducted by the University of Toronto.

Based on the assessment the proposed long-term phosphorus targets for the Bay of Quinte are:

- A threshold of a maximum of 40 ug TP/L, which cannot be exceeded 15% of the time in a year. This objective translates to a growing season average concentration of 25-27 µg TP/L; and
- The flow-weighted phosphorus levels in the major tributaries (Trent River, Moira River, Salmon River, and Napanee River) should not exceed 20 µg TP/L during the growing season May October.
- The Long-Term Target for chlorophyll-a (Chl a): not to exceed 12 µg/L more than 15% of time.
- The Long-Term Target microcystin (MC) should not exceed 5 µg/L more than 15% of time.

#### PROPOSED RESOLUTION:

THAT the staff report Restoring the Trenton Greenbelt Community Survey be received as information.

#### **BACKGROUND:**

From March 8<sup>th</sup> to March 31<sup>st</sup>, 2023, Lower Trent Conservation sought input from the public for its Restoring the Trenton Greenbelt Project. A short survey, consisting largely of multiple-choice questions was made available online. It was advertised through canvasing downtown Trenton, social media, print media, radio, and through direct contact with local groups such as the Downtown Business Improvement Association and the Rotary Club of Trenton. Before completing the survey, people were asked to view a 13 minute video describing the project, which can be viewed at the following link: https://youtu.be/mN3LyMm15xk


The survey informed the community of the project, and gathered information that will be used to guide its development. This information may also prove valuable when seeking future funding opportunities.

#### **DISCUSSION:**

108 people completed the survey, which was well above the expected response rate. Of these, 50 were from the Trenton core, 12 were from the Belleville core, 41 were from Prince Edward Country and surrounding Quinte West area. 58 respondents registered to be kept up to date on volunteer opportunities related to this project. Below are some highlighted results from the survey:

#### **VISITING THE GREENBELT**


- Only 25% of respondents say they visit the site.
  - Of those who do visit the site, the primary usage was Passing Through (33%), followed by Sitting and Relaxing (30%), and Dog Walking (19%)
  - Of those who do not visit the site, many stated that the site was "uninviting", "not appealing", and "run down".
- Respondents were asked how likely they would be to use the site after restoration is completed, on a scale of 1 to 5, with 1 being Very Unlikely and 5 being Very Likely. As demonstrated below, the majority of people stated they are more likely to visit.





#### **TRAILS**

• When asked what material the main trail should be constructed of, participants were in favour of a gravel or paved pathway, as demonstrated below:

• When discussing their reasoning for their trail preferences, accessibility was brought up in some form 59 times, demonstrating its important to the community.


#### **ART AND INFORMATION**

- LTC would like to install educational signage, as well as paint the weathered picnic shelter and tables.
  - When asked what they would like on the signage, the overwhelming majority of community members (44%) said "Signs describing the plants and animals you could see on site".
  - 34% of respondents stated they would like the picnic shelter to reflect "Themes related to the Trent River" and 27% would like to see a theme related to "Prairie-meadow plants and animals".

#### **OTHER**

- Those taking the survey were asked if they "Would you like to see more lawn to meadow habitat conversions on the Trenton Greenbelt Conservation Area and other green spaces in the future?", to which 94% replied "Yes"
- When asked what the most important feature of this site is, 42% of community members selected habitat
  creation for pollinators, but many also selected having places to sit and walk, as well as increasing climate
  resilience, as demonstrated by this chart:

- Some additional comments provided at the end of survey included:
  - o "Great idea and thank you for taking on this project to make Trenton much more attractive!"
  - o "more projects connecting our river to our community would be welcome improvements"
  - "This is a great project, I'm happy to see this under-utilized space being improved"
  - o "Thank you for providing such a wonderful opportunity for the community to learn about biodiversity, soil health and climate resiliency."
  - o "I am thrilled to hear about this project. I've often felt that this was an under-utilized space. I think it's particularly important to have green spaces with native plants in cities. Many residents wouldn't get out conservation areas outside of town, but would use a space like this. That type of access can encourage curiosity from kids and may lead to more involvement with wild spaces as they get older."

#### **CONSERVATION ONTARIO**

Following the Conservation Ontario Regular Council meeting on June 26<sup>th</sup>, CO is holding a GM/CAO two-day session June 27-28. It will be held at the Kingbridge Centre in King City.

#### **STAFFING**

It has been a busy spring with the onboarding of students, interviews and new hires.

The Conservation Lands Maintenance Assistant position was accepted by Nicholas Peat and he began working with the field crew on May 29<sup>th</sup>. This is a six-month position.

The Watershed Services Specialist position was accepted by Massimo Narini, previously employed at LTC. This position will be focussed on flood forecasting and warning, monitoring and stewardship. Massimo will start work later in June.

#### Students

Raven Chartrand and Jessica Livingstone are the Assistant Watershed Monitoring Technicians. Lauren Henry was hired as our Education and Outreach Assistant.

Jett Brown is a returning Conservation Lands Field Assistant. There is one additional Conservation Lands Field Assistant position which will be filled shortly.

Erica Francis is the Ontario Federation of Anglers and Hunters (OFAH) student housed within the LTC office. She is paid through the OFAH and works in conjunction with LTC staff.

#### **MUNICIPAL AGREEMENTS**

I have conducted meetings with five of our partnering municipal CAOs in the past three weeks to discuss the Memorandum of Understanding for our Category 2 and 3 programs and services. The feedback received to date has indicated that the senior staff understand and appreciate the services being provided. The financial aspect of the programs and services were discussed based on the 2023 budget but have not been finalized as LTC is just beginning our annual budget process.
