### **BACKGROUND:**

### REQUIRED CONSULTATION FOR THE SECTION 36 AMENDMENTS

The Trent Conservation Coalition Source Protection Committee has been working on amending the Trent and Ganaraska Source Protection Plans and Assessment Reports. They have completed the Early Engagement with the Ministry of the Environment, Conservation and Parks and Pre-Consultation Phases with policy implementers. Appropriate edits to the documents have addressed pertinent comments received. The final required consultation is the Public Consultation. This includes all agencies contacted in Pre-Consultation plus any individuals or businesses known to be affected by the proposed changes.

Staff is preparing the necessary documents and list of contacts. The target date for Public Consultation is September 1st running to October 5th. There will be advertising and a social media campaign running at the same time.

This email poll of the Lower Trent Source Protection Authority is being conducted to initiate the Public Consultation phase.

### PROPOSED RESOLUTION:

### **BACKGROUND:**

All aspects of the Section 36 Amendments are on schedule and proceeding as expected. The final document package is being compiled for submission to the Ministry of the Environment, Conservation and Parks. The package includes the amended Trent and Ganaraska Assessment Reports, the amended Trent and Ganaraska Source Protection Plans, the updated Explanatory Document, several updated Assessment Report maps and updated appendices. Each document will be submitted in Track Changes and a Clean Version. There are some final minor edits and formatting to complete.

After approval by the Ministry the documents are required to be AODA compliant before posting on the Trent Conservation Coalition website. The program will receive funding from the province to hire a consultant to meet this requirement.

Trent Bos has been working on a project to provide people with private drinking water systems with information to protect their sources of drinking water. On October 26, 2023 he hosted a webinar that was well attended and the feedback from the attendees has been very positive.

### PROPOSED RESOLUTION:

THAT the Lower Trent Source Protection Authority receive the Transfer Payment Agreement Status report as information.

### **BACKGROUND:**

The next Transfer Payment Agreement Period begins April 1, 2024. It is anticipated that it will be at least a two-year funding period but no details have been provided by the Ministry of the Environment Conservation and Parks to date. When details are provided, staff will prepare the funding request with the assistance of the Management Committee. The request will detail staff activities for the next two years.

Most of the staff's efforts for the past 5 years has been primarily focused on the Section 36 Amendments and with that stage nearing completion, there will be an opportunity for staff to work on other activities. These activities include developing Education and Outreach initiatives to be used across the region, for new policies in the Section 36 Amendments. There are many cases where Education and Outreach is the only tool managing some threats, such as road salt application and storage in smaller quantities.

There will also be an opportunity to work with municipalities to help them adjust to the new technical rules and Source Protection Plan amendments. The regional staff will be working on some necessary internal processes, such as dealing with Transport Pathways. Toward the end of the next 2-year period, early planning for the next Section 36 Amendments may be necessary.
